



Past OCP amendment app cat ons n Abbotsford, such as the one for 2774 and 2790 Stat on Road and nearby propert es (PRJ21-118), nvo ved chang ng and use des gnat ons from suburban to urban, wh ch resu ted n s gn ficant changes to ne ghborhood character. These changes often ead to ncreased traffic, no se po ut on, and pr vacy concerns for homeowners, d rect y affect ng the qua ty of fe and property va ues. Impact on Schoo s and Commun ty Spaces: The amendment wou d p ace new structures next to educat ona and recreat ona fac t es, wh ch h stor ca y have not coex sted harmon ous y w th h gh-dens ty deve opments. For nstance, the

app cat on for 33868 P ne Street (PRJ24-031) a med to trans t on from an Institutional to an Urban 1-M dr se designation, potent a y ntroduc ng a h gh-r se apartment bu d ng near estab shed commun ty areas. Such deve opments can ead to: Increased Traffic and Safety Concerns: More res dents mean more cars, wh ch cou d exacerbate congest on around the schoo, part cu ar y dur ng drop-off and p ck-up t mes, pos ng safety r sks to ch dren. Loss of Green Space: The construct on and subsequent population increase could pressure ex st ng green spaces, ke the dog park and pub c park, reducing the rut ty and access bity for the community. Historica Precedents n Abbotsford: Dens ty and Infrastructure: The C ty has faced cha enges wth nfrastructure when sudden ncreases n dens ty occur w thout correspond ng upgrades. Th s has been ev dent n areas where OCP amendments have ed to deve opments that the ex st ng nfrastructure was unprepared for, result ng n ssues with sewage, dra nage, and ut tes. Commun ty D srupt on: There have been notab e pub c concerns regard ng the ack of commun ty consultation or inadequate response to feedback, as seen with the w thdrawn app cat on PRJ21-193, where commun ty back ash was s gn ficant enough to cance p anned meet ngs and hat the project. Env ronmenta and Qua ty of L fe Cons derat ons: No se and Po ut on: Increased construct on and permanent res dent dens ty nev tab y ead to h gher eves of no se and po ut on, d rect y affect ng the tranque ty of our neighborhood and the we -being of its nhab tants, nc ud ng students attend ng the nearby schoo. D srupt on of Loca Ecosystems: The deve opment cou d further stran oca w d fe and p ant fe, d m n sh ng the eco og ca benefits that parks offer. In ght of these points, I urge the reconsideration of this OCP amendment. The potent a for negative mpacts on our ne ghborhood, part cu ar y w th ts d rect adjacency to a schoo and commun ty parks, far outwe ghs any proposed benefits. The h story of such projects n Abbotsford c eary nd cates the need for a more carefu approach to urban p ann ng that respects and preserves the qua ty of fe for ex st ng res dents and the ntegr ty of commun ty spaces. The ast th ng we need s more hous ng n th s ne ghborhood, n part cu ar th s corner wh ch s used for excess park ng for Ch ef parents and for park ng for the dog park, that for some reason has no park ng ot of ts own.

It appears that you are p ann ng on putt ng a home ess she ter or recovery house next to a schoo n a res dent a area. This is absolute y not the p ace for that. 22(1) goes to that schoo and t a ready has enough problems. We don't kneed home ess and drug add cts hang ng around the k ds, go ng into the schoo to use the washroom etc. You are setting these children up for failure, drug abuse, and a whole other assortment of ssues. Home ess she ters, though necessary, may a so br ng add t ona cha enges, such as a h gher ke hood of substance abuse or menta heath crses n the area, wh ch cou d affect the safety and we -be ng of both students and res dents. Wh e the she ter m ght address mmed ate hous ng concerns, t cou d create a r pp e effect of new prob ems, nc ud ng safety concerns for ch dren wa k ng to and from schoo, or for parents and teachers who may fee unsafe n the area. Furthermore, p ac ng a she ter near a schoo cou d mpact the overa earn ng env ronment, as students m ght exper ence anx ety or fear. The community s peace of mind could be deep y affected, and any ncrease n oca cr me or d sturbances cou d underm ne the qua ty of fe for everyone, espec a y those w th young ch dren. I urge the c ty to carefu y cons der a ocat on that s farther away from schoos and resident a areas to better address the needs of the home ess w thout comprom s ng the safety and we -be ng of fam es and students.


